## **EU POISED TO BAN ROUNDUP**

Europe is considering banning the herbicide Roundup because of a recent scientific report showing that the chemical (technically called glyphosate) kills beneficial insects. A ban would not only hurt Roundup sales, but would also affect the biotech crops genetically engineered to withstand the chemical. Independent research in Sweden has linked exposure to glyphosate with non Hodgkin's lymphoma, a form of cancer.

Canada's renowned geneticist and CBC host, Dr. David Suzuki, calls for a moratorium on genetically altered foods. He said Canadians have become unwitting guinea pigs in an experiment on our food supply. Dr. Suzuki stated that anyone who says these foods have been proven safe is mistaken because it would take decades of research to determine the safety of genetically engineered foods, which have only been around for a few years.

## **MONSANTO "BULLISH" ON FUTURE OF GM CROPS**

ORLANDO, Fla., March 7 (Reuters) Monsanto Co. will forge ahead with bringing its next wave of genetically modified crop seed to market despite the uproar in Europe and Asia over transgenic crops. Monsanto's vice-president for North American agriculture business said "We see the technology as very beneficial for the long term." said Carl Casale in an interview at a commodity conference there. "We are going to work through the issues. We are very, very bullish."

## **GE ROYAL COMMISSION – MORATORIUM OR NOT?**

At yesterday's organics/GE special interest group, there was concern over the government not allowing a moratorium on new field trials as part of the Royal Commission. It was suggested that as many people as possible write/call/email Helen Clark to urge her to act to stop all new trials in the open environment which will risk irreversible contamination.

The issue of food versus medical research is not the key concern (though important), it is the matter of safe containment or unsafe external trials. There is no way to prevent insects from biting transgenic animals, or eating transgenic trees, however carefully kept behind a fence or terminated before releasing pollen.

The complex interrelationships of life makes any outdoor trial an unacceptable risk to our future (which the Royal Commission is supposed to guide). Please urge people to call for a full moratorium on all new external field trials irrespective of the medical or agricultural focus.

## **PETITION FOR ROYAL COMMISSION INTO GE IN NZ**

92, 000 people signed a petition last year asking for a Moratorium on field trials of transgenic crops, animals or other organisms, and on the approval of any further transgenic foods for sale in New Zealand.

It was also requested of the House of Representatives that the Royal Commission hold public hearings in the main centres of NZ with cross examination of evidence.

This petition was ignored when it was presented to parliament. Every single person who signed this petition needs to express their concern to their local MP's and to the Prime Minister.

## **PRODUCT BOYCOTTS IN NEW ZEALAND**

There is a renewed call by customers for MILO to be made GE-Free. This kiwi icon is a family favourite and should be guaranteed not to have GE ingredients. People need to call the consumer hotline and ask when this will be? In the UK and Hong Kong the manufacturer

has agreed to go GE-free but only when it has "heard " from customers. The period of action is also expected to see people turn the product upside down in stores across the country to remind people to call and demand action. Phone 0800 – 830 840 and ask that Nestle NZ goes GE free here as well.

## **LABELING GE FOODS OVERSEAS**

The US and Canada, came under fire at a global summit on GE foods yesterday; over the thorny issue of whether consumers should be told they're consuming GM products.

Lisa Katic said, "Mandatory labelling could lead consumers to believe there are dangers (associated with GM foods)."

Katic was further cited as saying mandatory labels might force U.S. and Canadian retailers to purge GM foods from stores, where as much as 60 % of products contain genetically modified ingredients, mostly soybeans, corn and canola oil.

She said the growing niche market in organic foods would always leave consumers with a range of choice!

Ase Fulke, head of the Norwegian Food Control Authority, was quoted as saying, "If your customers don't know about it, you've effectively taken away their right to choose. Labelling must be mandatory."

Dr. Suman Sahai, a scientist from India said, "It's presumptuous and arrogant that someone else should decide on behalf of consumers." Sahai was also quoted, "I would like to know what Canada stands for. On one hand, you're supposed to lead an effort to establish labelling, on the other hand, you're working with the United States to sabotage it."

## **GENETICALLY MODIFIED CANOLA FOUND IN AUSTRALIA DUMP SYDNEY, March 25 (Reuters)**

Genetically engineered canola plants not yet approved for public release in Australia, have been found in a garbage dump; the Age newspaper reported on Saturday. The Melbourne paper said the experimental plants, contain multiple genetic modifications - including one for antibiotic resistance.

## **BIOTECH COSMETICS**

The European Commission is currently investigating biotech ingredients in cosmetics. Soya and corn, which can be genetically engineered, are used in a huge number of beauty products, including moisturisers, powder compacts, eye shadow, anti-aging creams and lipsticks. Antibiotic resistance genes, which are routinely included in many genetically engineered crops, are a major concern because of the fear they may be taken up by disease organisms and add to the growing number of antibiotic resistant diseases.

## **GENE SMUGGLING**

Dr Mae-Wan Ho, a molecular geneticist at the Open University in UK, explains that genetic engineering

bypasses conventional breeding by using artificially constructed parasitic genetic elements as vehicles called "vectors" to smuggle genes into cells. Unlike natural parasitic genetic elements that can only infect a limited range of hosts, the vectors used in genetic engineering are designed to overcome species barriers, and can therefore infect a wide range of species. ## GE ORGANS & 5 LITTLE PIGS

March 2000

PPL Therapeutics announces that 5 little pigs have been successfully cloned and the supply of organs for xenotransplants is as good as in the bag. In this country, where land is cheap and regulations lax, (Sunday Times 9.1.2000) up to 10,000 sheep with human genes have already been approved to be bred 'in containment' at Ruakura Research Station. Whilst the cows with human genes are still awaiting approval, could the GE pigs soon be on their way to NZ?

"Some researchers are warning that the transplanting of genetically altered animal organs into humans could result in animal viruses crossing species boundaries, creating deadly new viral epidemics for which there are no cure. With biotech companies anxious to supply genetically modified animal organs to tens of thousands of patients in need of transplants in the coming years, virologists are warning of the unleashing of viral pandemics of 'nightmare' proportions."

## VIT A RICE – IS IT GOOD FOR YOU?

The genetic engineering of Vitamin A rice deepens the genetic reductionism of the Green Revolution. Instead of millions of farmers breeding and growing thousands of crop varieties to adapt to diverse ecosystems and diverse food systems; the Green Revolution reduced agriculture to a few varieties of a few crops. From approx 100 to about 6, (mainly rice, wheat and maize) bred in one centralised research centre (IRRI for rice and CIMMYT for wheat and maize). The Green Revolution led to massive genetic erosion in farmers fields and knowledge, erosion among farming communities, besides leading to large scale environmental pollution due to use of toxic agrichemicals and wasteful use of water. Genetically engineered rice as part of the second Green Revolution is repeating the same mistakes, while adding new hazards in terms of ecological and health risks. Including possible Vitamin A poisoning.

The campaign to stop the genetically engineered bovine growth hormone (r-BGH) entering into the EU and Canada has been successful. The FDA failed to investigate studies showing that the oral feeding of rBGH led to thyroid cysts and prostate activity in male rats. The Health Canada study found that these results necessitated further study of the human health impacts of rBGH. The study also found that significant animal health problems were associated with rBGH use in dairy cows, including a 50% risk increase of lameness and a 25% risk increase of mastitis (udder infections).

However, the FDA approved rBGH for use in the U.S. in late 1993 without finding that it was safe for use and ignoring studies that indicated these human and animal health risks. In contrast, both Canada and the European Union have found the potential human and animal health problems associated with rBGH is great enough to prohibit rBGH use.

**Antibiotic Resistance:** Because rBGH use results in elevated mastitis levels, dairy farmers tend to use more antibiotics -- residues of these drugs may end up in milk and dairy products. These residues may cause adverse (i.e. allergic) reactions in a few sensitive individuals and contribute to the growth of antibiotic resistance in bacteria, now an important human health issue.

Neville Merton of the NZ Dairy Board Wellington tells me that the Dairy Board has not changed its stance on BST. They say that they will not use it and have banned the use of it due to consumer concerns. Though he also said that it was not economic to use it, as the price out weighed the financial returns of using it. This was a concern to me, that neither animal welfare or human health risks were being mentioned. The door is still open, for this or a similar product to be introduced into New Zealand, at a later date. The NZ Vet Association on the other hand stated that there was a complete EU ban on importation of any products which were produced using these hormones. They said that it would be extremely unlikely to get registration here in New Zealand.

## **GENETICALLY ENGINEERED FIELD TRIAL CROP DESTROYED IN AUSSIE** 8 March 2000

Activists from the Free Seed Liberation Front (FSLF) up-ended and trampled more than 200 genetically engineered pineapples in a field trial near Brisbane (Queensland) last night.

"Our governments should be directing research dollars into moving our society towards sustainable organic food production, rather than developing crops such as these pineapples, which are being developed purely to benefit the food processing and biotechnology industries." a spokesperson for the FSLF said. "Following the Federal Governments' pathetic backpedalling on labelling of genetically engineered foods yesterday, it's obvious they can not be trusted to act in the best interests of the people. It's time for us to take action. This is just the beginning of the people's movement against genetic engineering of our foods. We believe that genetic engineering of food crops will exacerbate the environmental problems caused by industrial agriculture and increase corporate control of the food supply through patenting genetic codes."

The field trial application to grow GE potatoes near Lincoln '98 stated that the object was to control the serious problem of bacterial soft rot in potatoes. Prior to the ERMA hearing; on contacting the main commercial potato growers in the Auckland region and other areas we were told that bacterial soft rot is not a problem in potato growing because: Resistant varieties of potatoes are already grown, and bacterial soft rot is a management problem. Solved by ensuring healthy soil, growing conditions, and correct storage of the crop. Which really introduces questions of the real motivation and purpose of the decade long field trialling of GE potatoes in NZ by Dr Tony Conners? (Has there been a crop this year, as they had approval for a five year trial?)

## **CHINA - HIGH LEVEL OF MODIFIED FOOD ON SALE**

An appeal for speedier labelling of genetically modified food was made by the Consumer Council yesterday. When the council released a survey that found one in five super-market products studied, contained GM ingredients. In a survey of 105 food products, the most commonly modified crops were soya beans, corn and tomatoes, 21 products were found to have GM contents. The nine products with the most genetically altered ingredients had from three to 50 per cent, including three baby formulas. Abbott Laboratory's Isomil Soy Protein Infant Formula had the top reading, 50 %, followed by Campbell's Golden Corn soup and Nissin Demae Ramen Instant Noodle, at 30 % each.

## **AUSTRALIA-WIDE PROTESTS SAY 'NO!' TO GE FOODS** World Consumer Rights Day - March 15

There were protests in most capital cities and many regional centres today over the presence of unlabelled, untested genetically engineered foods on supermarket shelves. An information leaflet was launched to mark World Consumer Rights Day and to counter government funded disinformation in supermarkets. "Access to information and the right to know what has been done to our food must be guaranteed by labelling," said GeneEthics Director Bob Phelps. "But our Prime Minister has delayed the labelling of processed foods containing imported GE soy, corn, canola, potato and sugarbeet, as well as local cottonseed oil," said Bob. "Health Ministers decided last year to label all foods produced using gene technology, but that may now be reversed and July 2001 is the earliest we may see labels," he said. "Howard has done the dirty on Australian food buyers, siding with US companies that claim to benefit US farmers but impose health and environmental hazards on us," he said. "On World Consumer Rights Day we demand our right to know what we are eating," he said. "With government support for the organic industry instead of GE, Australia could meet the huge demand for clean, green organic foods," he concluded. How does this impact upon us? By giving our decisions on labelling to ANZFA, has NZ lost its right to choose.

## HERBICIDE RESISTANT "FRANKENWEEDS" EMERGE IN CANADIAN CANOLA FIELDS

February 10, 2000  
The story says that volunteer canola resistant to three herbicide-tolerant canola systems has been found in a field in northern Alberta. Phil Thomas said, "We knew it was going to happen. It was only a matter of when." A series of chemical and DNA tests confirm the weeds in Tony Huether's field near Sexsmith are resistant to Roundup, Liberty and Pursuit chemicals. Canola scientist Keith Downey, who created modern canola, says the triple-resistant canola isn't a great problem, adding, "We haven't created a superweed or anything like that." He said that adding 2,4-D or a similar herbicide to a chemical mix will kill any wayward weeds, noting, "I don't think it means anything to consumers." [Web note: 2,4-D is a toxic herbicide]

Jenny Hillard, vice-president of the Consumer Assoc. adding, "The backlash now is so little based on fact, I know it won't make it any worse. The general public hasn't a clue of what's going on. They're frightened with so little science behind their fears. They need to get a handle on this or we'll lose the whole damn technology." "I feel that the results should be made public." Huether points his finger at the close relationship between chemical companies and government scientists, stating, "It's hush hush because research is funded to a large extent by big business. I'm losing more and more confidence in the whole system of research and how things are approved." <http://www.producer.com/articles/20000210/news/20000210news01.html>

## BIODEMOCRACY AND ORGANIC CONSUMERS ASSOCIATION

March 21, 2000  
Washington, March 21-An unprecedented coalition of more than 50 consumer, environmental, scientific, farm and health groups filed a legal petition with the Food and Drug Administration (FDA) today demanding the establishment of stringent pre-market safety testing regulations for genetically engineered foods (GE foods). Under the current FDA "non-labelling" policy, those suffering from food allergies have no way of knowing they are consuming GE foods or how to avoid this potential new source of food allergy. Health professionals are also concerned that the mass consumption of GE foods, most of which contain genetic material resistant to antibiotics, could eventually make treating infections more difficult. "The FDA has ignored the law and placed the interest of a handful of biotechnology companies ahead of their responsibility to protect public health," stated Andrew Kimbrell. "By failing to require pre-market testing and labelling of genetically engineered foods, the agency has made consumers unknowing guinea pigs for potentially harmful, unregulated food substances."
